



**Terms and conditions:**

**ENTIRE AGREEMENT**

This agreement contains the entire understanding between Irisweddings and The Client. It supersedes all prior and simultaneous agreements between the parties. The only way to add or change this agreement is to do so in writing, signed by all the parties.

**Booking Fee**

A booking fee of £200.00 ('The Booking Fee') is charged when the Client signs this contract. The Booking Fee is non-refundable if The Client chooses to cancel. If Irisweddings are not able to honour this contract, The Booking Fee will be re-funded. The Booking Fee is deducted (in full) from the total price as calculated by totaling fee due and album figures as detailed in the Invoice.

**Payment**

The Client agrees that a £200 deposit is required at the time of contract and 100% of the remaining balance is due at least 14 days prior to the event date. It should be paid in full to James Hacker. All prices fully include V.A.T. (If applicable).

**Display**

The Client hereby allows Irisweddings to display any images taken as part of this contract in their studios, portfolios, literature, wedding exhibitions, web sites, exhibitions, slide shows, competitions and advertising or any other purpose thought proper by Irisweddings. All copyright in the images is owned absolutely by the Photographer within the provision of the Copyright Design and Patents Act 1988.

**House Rules**

If the photographer is limited by the guidelines of the ceremony official or reception site management, The Client agrees to accept the technical results of their imposition on the photographer. Negotiation with the officials for moderation of guidelines is The Client's responsibility, Irisweddings will offer technical recommendations only.

**Licence**

The Photographers shall be granted artistic licence in relation to the poses photographed and the locations used. Due to the vagaries of the weather and the willingness of the subjects it may not be possible to capture all the images requested by The Client, but every effort will be made to achieve the best results.

### **Limitation of Liability**

Neither party shall be liable to the other for any losses that the other suffers as a result of the breach of the contract unless those losses are a foreseeable consequence of the breach. Irisweddings cannot be held liable under this contract where The Client is unhappy with the composition of any of the photographs where the Photographer has complied with their obligations as agreed on the contract.

### **Cancellation**

The Client may cancel this contract at any time after it has been signed by sending a written notice to Irisweddings and receipt of this has been acknowledged.

If The Client notifies Irisweddings more than 120 days before the date that the wedding is due to take place then The Client will not owe Irisweddings any percentage of the final fee.

If The Client notifies Irisweddings less than 120 days before the date that the wedding is due to take place then The Client will owe Irisweddings the following percentage of the final fee:

More than 120 days = 0%

60-120 days = 50%

30-60 days = 80%

15-20 days = 90%

8-14 days = 95%

0-7 days = 100%

### **EXPENSES**

Where extra expenses or time are incurred by Irisweddings as a result of alterations to the original brief by the Client, or otherwise at their request, the Client shall give approval to and be Liable to pay such extra expenses or fees to Irisweddings at a normal rate. In addition to the expenses agreed or estimated. Receipts will be provided.

**Use of Digital Files**

Copyright of the photos remains the property of Irisweddings. The photos on the CD cannot be re-touched in anyway and are not for re-sale or commercial gain. They are solely for the use of The Client to reproduce and distribute between friends and family only.

**Proof CD**

The Client will receive the CD of the coloured photos of their wedding within 14 days of the event.

**Book**

If The Client has chosen to have a book produced of their photos, upon receipt of the CD, they have 7 days to send a list of shots The Client would like in the book to Irisweddings. The book will be with The Client within 28 days. However, Irisweddings are not liable for any delays caused by outside companies.

**Complaints**

If The Client is not happy with the final product for any reason, they have to notify Irisweddings in writing within 7 days of postage of the product. Irisweddings will then work with The Client so both parties are happy but for no longer than 28 days after postage of the product.
